10.	<p><b>Notification regarding Acceptance of Alternate Documents for Identification of ESI beneficiaries</b></p>	<p>the Ministry of Labour and Employment released notification S.O. 3792(E) on August 19, 2025, mandating that the Employees' State Insurance Corporation (ESIC) must accept alternative identification documents for ESI beneficiaries if Aadhaar authentication is not provided. The notification clarifies that Aadhaar authentication is voluntary and that beneficiaries who decline it cannot be denied ESI benefits. Instead, they can use a Passport, PAN card, or Driving License for identification. Please refer to more details as per Annexure 10</p>

As per the Notification No.DES/1251/2024-P3(1),The Consumer Price Index (Cost of Living Index) Numbers applicable to employees in employment under the Minimum Wages Act (Central Act XI of 1948) for the month of June 2025 as ascertained by the Director General of Economics &amp; Statistics under clause (C) of Section 2 of the Act. 14.	<b>Office order regarding implementation of the Sexual Harassment of Women at Workplace (Prevention, Prohibition and Redressal) Act, 2013 in Karnataka</b>	<p>The Government of Karnataka released an office order, referencing file number GGDAT/CIA30/2023-2024, concerning the implementation of the Sexual Harassment of Women at Workplace (Prevention, Prohibition and Redressal) Act, 2013, which aims to provide protection and a redressal mechanism for women against sexual harassment at their workplaces. This order mandates compliance with the Act and the constitution of internal committees to handle such complaints. Please refer to the notification for more details <b>as per Annexure 14</b></p>

15.	<p><b>Notification of the Punjab Shops and Commercial Establishments (Amendment) Act, 2025 in Punjab</b></p>	<p>The provisions of the Punjab Shops and Commercial Establishments Act, 1958, shall apply to shops and establishments employing twenty or more workers, whereas only section 13-A shall be applicable to shops and establishments employing fewer than twenty workers. The amendment aims to provide relief to small businesses by reducing compliance burdens, increasing operational flexibility, and promoting entrepreneurial growth through measures such as decriminalizing certain non-compliances and increasing permissible working and overtime hours. 16.	<p><b>Notification regarding the Display of Bengali Language on Top of All Signage's in KMC, West Bengal</b></p>	<p>The Kolkata Municipal Corporation, Government of West Bengal Vide Municipal Commissioners Circular No.34 of 2025-26, has released Notification regarding the Display of Bengali Language on Top of all commercial signboards, including hoardings, in West Bengal, with a <b>deadline of September 30, 2025</b>, for implementation. This rule requires shops and other businesses to prominently feature Bengali on their signs alongside any other languages used, underscoring the official language's importance in the state.
